### STORAGE AND MAINTENANCE

To remove any contamination, rinse the Chemsol HG Lite clothing with cold water and allow it to drip dry in a shaded area, away from UV sources. It is advisable to store Chemsol HG Lite clothing in a cool, dry, and clean environment.

**NOTE:** For hygiene purposes, it is recommended that the garment be worn by the same individual. **Fabric is a Biocidal Treated Article** - Fabric is treated with anti-bacterial, (Active Ingredient: Zinc Pyrithione), with the sole purpose of controlling organisms harmful to the treated article/fabric itself.
